# Draw: 5:00pm daily during ADX Melbourne

# **ADX Melbourne Promotional Game Terms & Conditions**

Australian Dental Industry Association (ADIA) is holding ADX Melbourne in 2023. ADX Melbourne includes a significant giveaway to promote the event, and the goods and services available from exhibitors and sponsors at the event. This giveaway is conducted as a trade promotion lottery in accordance with the Victorian Government requirements. The game is conducted to promote the goods and services provided at ADX Melbourne.

## **Purpose**

1. This trade promotion lottery is conducted to benefit primarily the Australian Dental Industry Association Ltd.

## Name of the Person Conducting the Trade Promotion Lottery

2. The game is being conducted by Kym De Britt on behalf of Australian Dental Industry Association Ltd.

#### **Key dates**

- 3. The promotion period is 1 January 2023 to:
  - 3.1 Day 1 draw: Thursday 30 March 2023
  - 3.2 Day 2 draw: Friday 31 March 2023
  - 3.3 Day 3 draw: Saturday 1 April 2023
- 4. The random prize draw will take place at 5.00pm at ADX Melbourne, Melbourne Convention & Exhibition Centre on:
  - 4.1 Day 1 draw: Thursday 30 March 2023
  - 4.2 Day 2 draw: Friday 31 March 2023
  - 4.3 Day 3 draw: Saturday 1 April 2023

#### The Prize

- The prize is two Grandstand tickets to the Melbourne Formula 1 Grand Prix for Sunday 2 April 2023.
- 6. The winner may choose to transfer their prize to another person.

#### **Eligibility Requirements**

- 7. Entry is free.
- 8. Entry is open to all ADX Melbourne visitors who have registered as ADX Melbourne visitors, who were scanned in on arrival and who are present at the time of the draw.





9. Employees and immediate family members of employees of ADIA, ADIA members, ADX Melbourne exhibitors, ADX Melbourne sponsors and ADAVB are ineligible to enter.

#### **Entry**

- 10. Eligible Entrants are automatically entered into the draw during the promotion period.
- 11. Each entrant has a fair and equal chance of winning the prize.
- 12. The game does not involve a round in which players are eliminated.
- 13. Entrants are required to be present at the drawing of the lottery to be eligible to win.

# Selecting the winner

- 14. Each ticket in the draw has a random and equal chance of being drawn.
- 15. The winner of the draw will be announced via a microphone immediately after it is drawn.
- 16. The winner must be on the premises when their name is announced to be eligible to claim their prize.
- 17. The winner has 1 minute to identify themselves and claim their prize from the time their name is announced.
- 18. ADIA will make every reasonable effort to locate the prize winner by announcing their name three times, and providing a partial countdown until the redraw if the winner does not immediately identify themselves.

#### **Redraw if Winner Not Present**

- 19. If the prize is unclaimed within 1 minute of the announcement, the first winner is deemed ineligible by virtue of not being present at the time of the draw, and a subsequent draw will be conducted.
- 20. If the prize is unclaimed within 1 minute of the announcement, the redraw process will be repeated until a winner is found.

#### **Notification of winner**

21. The winner will be notified in person when the draw is conducted, and subsequently in writing.

#### Accepting the prize

22. The winner does not incur a non-trivial cost for accept the prize. There may be trivial costs such as travelling to the Formula 1 Grand Prix ticket area to utilise the prize.

#### **Prize Delivery**

- 23. The prize will be transferred to the winner immediately after the draw.
- 24. If the prize is not claimed immediately, it may not be possible to provide the prize in timely a manner to facilitate the winner utilising the prize.

#### **Publication of Results**

25. The name of the winner will be published on the ADIA website for a minimum of 28 days.

#### Use of information

26. Information about entrants obtained in the course of conducting the lottery will only be used for the purposes of conducting the lottery and complying with local regulations relating to the conduct of the lottery.
