# **CONSTITUTION CHANGES**

#### 13.1 NUMBER OF DIRECTORS

- 13.1.1 The Credit Union must have such number of directors being not less than 7 and not more than 10 as the Board from time to time determines of which:
  - (a) not more than 7 may be elected or appointed by members ("elected director"); and
  - (b) not more than 3 may be appointed by the board ("appointed director")

# Changed to:

- 13.1.1 The Credit Union must have such number of directors being not less than 5 and not more than 9 as the Board from time to time determines of which:
  - (a) not more than 6 may be elected or appointed by members ("elected director"); and
  - (b) not more than 3 may be appointed by the board ("appointed director")

The purpose of this change is to allow for flexibility in the board size and composition. However, still allowing the board to appoint as directors persons with specific skills, knowledge and experience to complement the combined competencies of the board. This will give the board the power to address issues of overall board competence and composition, in line with the Prudential Standard on Governance, should the need arise.

# NOMINATIONS FOR POSITIONS OF DIRECTORS

In accordance with Section 13.4 and 13.5 of the Constitution two (2) Directors retire. They are D Butler and T Robinson and are eligible for re-election. Nominations will be accepted on the Form available at the Registered Office of First Choice Credit Union. Nominations close at 5.00 pm Thursday 24<sup>th</sup> September 2020.
