5. Singles Rubber is to be played first in Singles/Doubles Rubbers sections.
Venue Supervisors have the authority to apply exceptions to this to organise the shortest possible time for matches played at the same venue. If unsure, please contact Match Convenor (Trevor Smyth) on 0468 958 927.
6. **A reminder that all Senior presentations are to be made at Doveton after matches completed.**
All clubs are expected to have at least one player or club official attend the presentation afternoon to collect their trophies and/or pennant. If a club is unable to attend, it would be appreciated if a courtesy call, or text, is made to our Match Convenor as soon as possible after the completion of the match.
