HOT SHOTS MATCH PLAY

TERMS & CONDITIONS

- 1 Each player must submit an entry form and the correct entry fee must accompany each entry form.
- 2 Matches will be played using modified balls and modified size court areas based upon orange or green ball competencies.
- 3 Play will commence punctually at the same time each week. Whatever the court conditions may be, players must be ready to play at the time appointed.
- 4 Should the match be cancelled or incomplete due to weather or other unforeseen circumstances (including player injury or illness), no refunds will be made.
- 5 Recognised tennis attire and footwear should be worn.
- 6 The competition will be governed by the Waverley Tennis *Guidelines to Competition By-laws*.
- 7 All players participate at their own risk.

CONSENT TO USE IMAGE: In consideration of my participating in the Waverley Tennis Hot Shots Match Play, I consent to Waverley Tennis taking, retaining and reproducing my image or likeness obtained during my participation in photographs, electronic images, sound recording and video footage and to use such image or likeness for the purposes of any promotional, advertising, research or marketing materials.

RELEASE AND INDEMNITY: In consideration of my participating in the Waverley Tennis Hot Shots Match Play, I agree to release, defend, hold harmless and indemnify Waverley Tennis and its directors, officers, employees, volunteers and agents from and against any actions, claims, demands, expenses and liabilities howsoever arising from any injury, loss or damage incurred or suffered in connection with my participation.

CONDUCT: In participating in the Waverley Tennis Hot Shots Match Play, I consent to being bound by all applicable Waverley Tennis by-laws, policies, rules and procedures. I further agree to comply with all directions issued by Waverley Tennis from time to time at or in connection with the Waverley Tennis Hot Shots Match Play.

In the event I am found using or in possession of alcohol or non-prescribed drugs forbidden by law, or smoking cigarettes, or behaving in a manner deemed by Waverley Tennis as being a safety risk to others or having the effect or possible effect of bringing Waverley Tennis or the sport into disrepute, I acknowledge and accept that Waverley Tennis may direct me to cease participating in or leave the Waverley Tennis Hot Shots Match Play and that I will comply with such direction at my own cost.
