From Director Student Wellbeing & Inclusion

Dear St Mary's College,

Our school theme for 2022 invites us to do good things together. As a staff, we see a strong alignment with a focus on Inclusive Education, considering how we foster environments for learning and wellbeing that support the flourishing of every student. During our recent staff formation day, our focus was on working with students with disabilities.

As part of my Master of Education Research, I explore how we include, welcome, and engage all students within our school systems. I came across a partnership between Purple Orange and

Flinders University, which studied inclusive school communities.

Purple Orange describes itself as "a social profit organisation on a mission to create a world where people who live with disability get a fair go at what life has to offer." Our presenters, Leeanne and Lauren (a St Mary's Old Scholar), both have lived experiences of disability.

Lauren and Leeanne explored the following:

- In society, disability is viewed as a deficit, yet most people with lived experience of disability do not see themselves this way.
- The medical model of disability see it as a problem of the person they are 'disabled' by their impairments/differences we need to shift this more towards understanding barriers that deny or limit access for people with disabilities
- The importance of language in understanding and naming disability.
- Universal learning design can be used in schools to shape the physical environment, learning, communication and assessment

Lauren and Leeanne raised awareness about unconscious bias, as described by Ing Ward-Wong, a disabled activist:

"People shouldn't be afraid of addressing their own biases when it comes to disability. Many of us grew up with this notion that to look at a disabled person is to look at someone lesser than you, that a disability is something to be pitied because that person isn't able to do what a non-disabled person, can do. We need to shed that as a society. We all have limitations, and we all bring different strengths to the table. If we look at disability from the perspective of someone who's living with a disability, who doesn't see themselves as lesser, who doesn't see themselves as a super-human or a charity case, we'll be able to have some of these difficult conversations about what accessibility and inclusion mean for people with disabilities in the 21st century".
