From the Principal

Dear St Mary's College,

This week we celebrate the Feast of St Dominic. Internationally, the Dominican Order is celebrating its Jubilee, the 800th anniversary of Dominic's death. The theme for the Jubilee is At the Table with Dominic. Being gathered at table is one of the places we build rich relationships with others. We gather with friends and family, share food and drink, tell stories, debate, learn from one another. Significant discoveries are made, conflict is resolved, relationships are forged as people gather at table. It is a rich symbol that lives at the heart of the Christian tradition with the Last Supper.

I share a home with my husband and two of our four young adult children. All of us are engaged with levels of work, study, leisure and social pursuits. Life in our household, like many others, is busy. Gathering at table is something we do each night during the week; the cooking duties are shared and once we sit down, phones are not allowed - unless we need Google to resolve a debate! We reflected again recently, that the lockdown meant we were all home, there was nowhere else to be. A little more time was taken to prepare good food and sit longer at table talking because there was nowhere to race off to. During each of the lockdown times, this is something we have enjoyed.

The Roman Stoic Seneca (4-65CE), a philosopher-counsellor to the emperor Nero, was exiled by Emperor Claudius. During the time, he wrote to his mother to console her, sharing his thoughts on how we can respond in helpful ways when things are not as we wish. Some of his key ideas include: to work with what we can change; focus on what we can be sure about; keep a great perspective; have a role model; hope for the best and enjoy what is in our power. These seem like valuable ideas to guide us through the times we are living in.

From the Deputy Principal

Here at St Mary's College, parents can become involved in our community through a number of different avenues as volunteers – Friends of Music group, Friends of Sport group, on excursions, and so forth. However, before doing so, as part of our Safeguarding Children responsibilities, there is a process for all staff and volunteers who work with our children and young people to go through.

Child Safety Screening Procedures For Casual Employees, Contractors, Tutors, Pre-Service Teachers/Social Workers, Volunteers And Guest Presenters/Speakers has been developed in light of the National Safeguarding Children Standards. Its purpose is:

- To strengthen the process for taking on employees, contractors, tutors, pre-service teachers/social workers, volunteers and guest presenters/speakers who don't usually go through the formal employment process.
- 2. To centralise the screening process from expressions of interest to formal applications.
- To outline the storage and documentation process for screening procedures.

These procedures apply to all staff, contractors, tutors, pre-service teachers/social workers, volunteers and guest presenters/speakers, and is supported by staff working within or for St Mary's College.

All volunteers are required to provide a Working With Children Check (WWCC), Responding to Abuse and Neglect 2 hour volunteer training certificate and the names and contact details of two referees to the school.

A Catholic police clearance is also undertaken, by the school. Once all the relevant paperwork has been submitted, the Catholic Police Clearance has been conducted, and the referee checks undertaken, volunteers will be invited in for an Induction. It is only after all of these steps have been conducted, including the Induction, that volunteers can start.

Therefore, we would advise any parent who wishes to volunteer at the school in any capacity (including on excursions) to perhaps think and plan ahead and start the process sooner rather than later. The process can't be something that's undertaken at the last minute, due to the steps and time

Subject Selection Time

Although we are just over half-way through this year, we are about to hit a very exciting time in the Senior School calendar with our current Year 10 and Year 11 students selecting subjects for 2022.

As our Senior students plan to move into Stage 1 and 2 of their SACE journeys, they have a greater opportunity to focus on their individual areas of interest and explore their future pathways post school.

We support students in making these decisions with our Subject Selection Information Sessions and Subject Expos for Year 11s on Wednesday 11 August, and Year 10s on Wednesday 25 August. The Expo gives students an opportunity to look at samples of student work, course outlines and ask Learning Area Leaders questions about specific courses.

Conversations with Subject Teachers are also crucial. Students need to engage with their teachers and have them sign-off on their request to undertake a subject in 2022 on their Subject Selection Form.

Our 2022 Curriculum Information Book can be found on our website explaining all subject details. Other good sources of information are the 2022 SATAC Guide and University and TAFE websites. It is also a great idea to go to the University Open Days from 13 - 15 August.

The RACI Australian National Titration Competition, run by the Royal Australian Chemical Institute, is designed to encourage secondary students who enjoy Chemistry to develop their scientific skills and understanding. 

Commonwealth School Data Collection Notice

The Australian Government Department of Education, Skills and Employment (the department) would like to advise all parents and guardians that it collects certain information about your child's school, its staff, and student body.

Why is this information collected?

This information is collected by the department in accordance with the *Australian Education Act 2013* (the Act) and the *Australian Education Regulation 2013* (the Regulation). The Act and the Regulation require the legal entity responsible for the administration of the school (the Approved Authority) to provide certain information to the department. The department collects this information to:

- Ensure the provision of Australian Government funding to schools is properly calculated and appropriately managed.
- Conduct research, statistical analysis and develop school education policy for the Australian Government.
- Meet national and international reporting obligations on school students in Australia.
- Publish and provide information about schools to the public.

How is information collected?

Information is provided to the department by a school or their approved authority via various data collections on the <u>SchoolsHUB website</u>.

What information is collected?

Each data collection fulfils a separate reporting requirement. The data collections conducted through SchoolsHUB are:

- The Student Residential Address and Other Information Collection (Address collection)
 provides student residential addresses (excluding student names), and the names and
 addresses of parents/guardians of students for eligible full or part-time primary and secondary
 students enrolled at most non-government schools.
- The Financial Accountability (FA) assurance activity is done to certify that the financial
 assistance provided by the Australian Government for schools has been spent or committed to
 be spent to provide school education.
- The Financial Questionnaire (FQ) reports the income, expenditure, assets and liabilities from all non-government Australian schools receiving Australian Government recurrent grant funding.
- Student Attendance (STATS) provides a school's student attendance rate data by grade, gender
 and indigeneity from non-government schools for full-time students in Years 1 to 10 attending
 regular and special schools.
- The Non-Government Schools Census (Census) provides information about the number and
 characteristics of the school's staff and student body during a specific reference period.
 Characteristics include student year level and workload, Aboriginal and Torres Strait Islander
 staff and students, students with disability, students receiving distance education, boarding
 students, and overseas students. The names of students and staff are not collected, apart from
 the name, position and contact details of the staff member nominated as the primary contact
 for the annual census.

Census Special Circumstances Applications may also be made by schools to include a student/s
who did not attend during the Census reference period but otherwise meets Census eligibility
requirements. Schools will provide the department with information and documents about the
student demonstrating their eligibility. The department does not require information that
personally identifies a student and asks schools to de-identify any documents before providing
them.

How will the information be used and disclosed?

Some of the information collected by the department from schools in accordance with the Act and the Regulation, may be 'personal information' for the purposes of the *Privacy Act 1988* (Privacy Act). Personal information is protected by law, including under the Privacy Act. Any use or disclosure of your personal information must occur in accordance with the Regulation. Personal information is information or an opinion about an identifiable individual. Personal information includes an individual's name and contact details.

Personal information collected by the department may be used or disclosed for the following:

- Used by the department to review school funding calculations and develop school education policy.
- Used or disclosed where it is otherwise required or authorised by law, including under the Act or Regulation, or otherwise permitted under the Privacy Act.
- Disclosed to the Australian Bureau of Statistics to calculate your non-government school community's capacity to contribute to the costs of schooling (Address collection only).
- Disclosed to the Australian Curriculum Assessment and Reporting Authority (ACARA) to publish on the <u>My School website</u> and include as high-level data for ACARA's National Report on Schooling in Australia and the Productivity Commission Report on Government Services (Census and STATS only).
- Disclosed to state and territory education departments and authorities in accordance with the Act.
- Disclosed to a contracted auditor where the department decides to audit or verify the information
 provided by an approved authority about a school. The contracted auditor may use previously
 collected information or request access to individual student records for comparison purposes. The
 contractors may pass this information onto officers within the department, if there is a discrepancy
 in the data provided by the school and the school's records and further investigation is required.
 The contracted auditor must handle personal information in accordance with the Privacy Act.
- Disclosed to its service providers for the purposes of the provision of information and communications technology (ICT) support services to the department.
- Other than in exceptional circumstances (for example, investigation of fraud relating to overseas students), the department does not disclose any of the personal information collected to overseas recipients.

Protecting your child's privacy

When student information is provided to the department by schools or approved authorities, the department requests that the information must not explicitly identify any student. For example, student names or student identifiers are not provided. To help protect your child's privacy, we support schools to submit their reporting requirements using de-identified records.

In limited cases, even without student names or identifiers, a student may be reasonably identifiable from the information provided (for example, because of the small size of a particular school). In this event, the disclosure of such personal information to the department by a school, and the collection of that personal information by the department, are both required and authorised by law for the purposes of the Privacy Act.

What do you need to do?

You do not need to do anything. Your school is responsible for providing the requested information to the department.
