**1. Finance**

Gleeson College will be facilitating a Laptop loan arrangement for families who request it. This device will incur a \$100.00 bond (refundable on return of the device in a satisfactory condition at year end), as well as a loan fee of \$225.00 per annum, both payable **prior** to receiving the device. Please contact Reception to arrange payment, then a receipt and this form can be presented to the IT Department for provision of equipment.

**2. Conditions/Agreement**

- 3.1 We have read, understood and agree to the conditions as set out in the **Computer/Network Policy** available to students via the Student Information Pack on SEQTA and also published on the College website <https://www.gleeson.sa.edu.au/college-expectations---policies.html>
- 3.2 We understand and agree that failure to comply with these conditions could result in recall of the laptop and/or loss of access for home use and/or costs associated with repairs or replacement of the laptop while in the care of the student.
- 3.3 **The Student will bring the laptop to each lesson, daily, fully charged.**

**My responsibility as a Parent/Caregiver includes:**

- Reading the Computer/Network Policy (link provided above) carefully and discussing it with my child so we both have a clear understanding of our roles in using computing devices in learning.
- Ensuring this Agreement is signed by my child and by me and returned to the school.
- Encouraging my child to follow the cyber-safe strategies.
- Enquiring as to whether my personal home contents and car insurance will cover equipment on loan to my child, in the event of loss and/or damage to such loaned equipment while in the care and custody of my child.
- Acknowledging this laptop will not be covered by Gleeson College for loss and/or damage and that I may be liable for the replacement cost of the laptop.
- Contacting the school if there is any aspect of the Computer/Network Policy or this Laptop Loan Agreement I would like to discuss.
