Information

The inaugural **Yumbah Aquaculture Kangaroo Island YOUTH Employment Award** will be held in 2018, celebrating the contribution that youth make to local businesses and the economy of Kangaroo Island.

The event's proponent is ATEC (Adelaide Training and Employment Centre) – a service provider to businesses and employers, employees and job seekers, with local representation.

Award Objectives

Many Kangaroo Island youth complete training whilst working, to improve their skills and capabilities. Others return to the island, to work during their holidays, taking advantage of the busy periods for tourism. Whatever the reason, they are an integral component of the workforce available to the many and varied businesses on Kangaroo Island.

Judging

The judging will be completed by a panel of 3 persons, each having experience in training, employment, industry sector, leadership or education.

The judge's decision will be final. There are no avenues for reconsideration of the judge's determination of awards.

Eligibility

To be eligible for the award, applicants must be:

- 1. a youth (defined in South Australia as a person aged between 12 and 24 years)
- 2. completing further studies (may be a traineeship, apprenticeship, TAFE, University, or other recognised training)
- 3. working on Kangaroo Island (may be part-time, full-time or casual, including holiday employment)
- 4. a resident of Kangaroo Island (if the youth employee now resides off Kangaroo Island, then they originally needed to reside on Kangaroo Island before leaving for further studies)

Criteria

To be successful in gaining an award, the application must respond to the following criteria, providing details and examples of the youth employee's work history:

Criteria 1: Initiative

How has the youth employee demonstrated their initiative whilst in your employment?

Criteria 2: Skills

- How has the youth employee demonstrated their skills whilst in your employment?
- Can you detail how, if any, skills have improved due to training currently undertaking?

Criteria 3: Leadership

- How has the youth employee demonstrated any leadership attributes whilst in your employment?
- How has this demonstration of leadership positively affected your business?

Criteria 4: Additional Responsibility

- Has the youth employee taken on additional responsibility whilst in your employment?
- How has this benefited the youth employee (ie extra hours, additional pay, promotion)?
- How has this benefited your business?

- No extensions will be considered or granted.
